INVITATION TO BID FOR EXTENSION AND RENOVATION OF PRO 12 GRANDSTAND

1. The PNP Police Regional Office 12, through the Approved POE-PA of the Trust Receipts for the Month of February 2020 intends to apply the sum of **Fifteen Million Five Hundred Seventy Nine Thousand Five Hundred Twenty Four Pesos and 14/100 (P15,579,524.14)** being the Approved Budget for the Contract (ABC) to payments under the contract for the **Extension and Renovation of PRO 12 Grandstand/ITB No. PRO12-TRF-Cons#2020-01**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The PNP Police Regional Office 12 now invites contractors registered and classified by the Philippine Contractors Accreditation Board (PCAB) bids for **Extension and Renovation of PRO 12 Grandstand**. Completion of the Works is required **two hundred ten (210) calendar days**. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in **Error! Reference source not found.**
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act."

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.
4. Interested bidders may obtain further information from PNP Police Regional Office 12 and inspect the Bidding Documents at the address given below from **8:00 AM to 5:00 PM during working days**.
5. A complete set of Bidding Documents may be acquired by interested bidders on **September 16, 2020 to October 5, 2020** from the address below *and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Twenty-Five Thousand Pesos (P 25,000.00)***.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.
6. The PNP Police Regional Office 12 will hold a Pre-Bid Conference on **September 23, 2020, 9:00 AM** at **Multi-Purpose Hall, PRO 12, Tambler, General Santos City** which shall be open to prospective bidders.
7. Bids must be duly received by the PRO 12 BAC Secretariat at the address below on or before **October 5, 2020, 9:00 AM**. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.1.

Bid opening shall be on **October 5, 2020, 9:00 AM** at **Multi-Purpose Hall, PRO 12, Tambler, General Santos City**. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.


8. Only bids which shall be rated "pass" in their technical requirements will be opened. The bidder with the Lowest Calculated Bid (LCB) shall advance to the post-qualification stage in order to finally determine its responsiveness to the financial requirements of the project. The contract shall then be awarded to the Lowest Calculated and Responsive Bid (LCRB) who determined as such during post-qualification.

All particulars relative to the eligibility documents, bid security, performance security, pre bid conference, evaluation of bids, post qualification and award of contract shall be governed by the pertinent provisions of R.A. 9184 and its Revised IRR.

9. The **PNP Police Regional Office 12** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
